Dear Shareholders,

The Investor's Education and Protection Fund Authority ["IEPFA"], Ministry of Corporate Affairs ["MCA"] has via email communication dated July 18, 2025 requested companies to launch a **100 days Campaign - "Saksham Niveshak"**, to reach out to shareholders whose dividend remain unpaid/unclaimed.

Since dividends on shares are payable only through electronic mode for shareholders with unpaid/ unclaimed dividends, the amount will be credited to the shareholder's bank account only after the required information/documents are updated.

Shareholders are requested to approach Company/ RTA to claim their unpaid/ unclaimed dividends so as to avoid transfer of same to IEPF authority.
