Benefit to shareholders: It's important for shareholders to update PAN; Nomination details, contact information [postal address, mobile number], Bank account details with their respective Depository Participants [DPs] where they maintain their demat accounts.

Since dividends on shares are payable only through electronic mode for shareholders with unpaid/ unclaimed dividends, the amount will be credited to the shareholder's bank account only after the required information/documents are updated.

Shareholders are requested to approach Company/ RTA to claim their unpaid/ unclaimed dividends so as to avoid transfer of same to IEPF authority.
