The Board and Committee meetings of the Company are held at least on a quarterly basis and members of the Board meet key functional/business heads separately to get themselves more familiarized with the business/operations and challenges faced by the industry on an ongoing basis. The Key Managerial Personnel/ Senior Management/ Business Heads also conduct programmes / presentations periodically to familiarize Independent Directors with the operations and functions of the Company.
